

European Quality of Government Index


Governance

Anti-fraud provisions in European Structural and Investment Funds

Article 125(4) c) of Regulation 1303/2013

"As regards the financial management and control of the operational programme, the managing authority shall put in place effective and proportionate anti-fraud measures taking into account the risks identified."

Fraud and corruption prevention in area of Public Procurement




Measuring performance of Public Procurement

Limited competition

- ✓ Too many contracts for single bidders
- ✓ Not always collusion
- ✓ Low value for money?
- ✓ More e-procurement
- ✓ Better information
- More offers from outside the country

Post – 2020 Enabling condition - procurement

- 1. One of the 4 **horizontal enabling conditions** Annex III of CPR
- **2. Condition for submitting payment** applications (Article 11 CPR)
- 3. No more action plans: need to be fulfilled from the beginning
- Need to be complied with throughout the whole period (MC and ARM follow-up)



Enabling condition – procurement Overall objectives

- Verifying and reinforcing the effectiveness of procurement system: quality and intensity of competition (7th Cohesion Report)
 - ✓ Information on bidders, selection rate, prices,...
 - ✓ Participation of SMEs
 - ✓ Effectiveness of the remedy system
 - ✓ Recourse to exclusion from procurement rules
- Transparency
- Reporting and follow-up




Expected outcome

Information gathered through this monitoring mechanisms shall be used for:

- Gathering intelligence on procurement for improving the framework (such as participation of SMEs)
- Identify deficiencies within contracting authorities (high selection rate, inflating prices,...) tackled through:
 - ✓ Guidance and trainings
 - ✓ Focussed audits and controls
- Combatting bid rigging
- Build higher transparency and confidence in procurement system



Digital Transformation in Public Procurement






The Only Once Principle

(Public institutions should avoid to ask companies or citizens for documents or information that is already stored (and treated) by another public institution)

ESPD has information on how a supplier needs to qualify



National database contains the **actual evidence** or information about the supplier. **eCertis** has information on what evidence the supplier needs to provide



Digital Transformation

in Public Procurement:

- Blockchain examples in contract management or suppliers registries;
- AI (Artificial Intelligence) or ML (Machine Learning) examples in automated contract structure or forecasting needs;
- AR (Augmented Reality) and VR (Virtual Reality) examples in simulating new environments in public works;
- Voice Personal Assistants Chatboxes examples in assisting both CAs and EOs during the procurement process.
- Robots, Drones and Self-Driving Safety Features in Vehicles
- 3D Printing
- Cloud services



Data availability

- ✓ Data quality challenges;
- Growing interoperability potential;
- ✓ Possibility to apply new emerging technologies.





Other important developments and policy initiatives



Important policy initiatives

- Directive (EU) 2017/1371 of the European Parliament and of the Council of 5 July 2017 on the fight against fraud to the Union's financial interests by means of criminal law (so-called "PIF Directive")
- Objective: to deter fraudsters, improve the prosecution and sanctioning of crimes against the EU budget, and facilitate the recovery of misused EU funds
- PIF directive will be a major part of the law to be applied by the future EPPO



European Public Prosecutor's Office (EPPO)

- 12 October 2017 the regulation establishing the European Public Prosecutor's Office (EPPO) was adopted
- 22 member states have been confirmed in the enhanced cooperation on the establishment of the EPPO.
- EPPO is envisaged to take up its functions by the end of 2020.
- The EPPO will be an independent and decentralised prosecution office of the EU, with the competence to investigate, prosecute and bring to judgment crimes against the EU budget, such as fraud, corruption or serious cross-border VAT fraud.
